Membership category

WFA has three membership categories. All companies with annual production **below 2000 tonnes** join as **Small Winemakers** and are represented by the Small Winemakers' Membership Committee.

Membership levies also are determined by size.

Companies with **annual production below 500 tonnes** pay a base fee of \$400 plus \$3 per tonne on production between 100 and 500 tonnes. Complete Section A.

Companies with **annual production between 500 and 2000 tonnes** pay a levy based on their gross domestic and export sales revenue. Complete Section B.
